## Minutes from the MDTSEA Board of Directors Meeting September 10, 2010

President Bea Kehr convened the meeting at 10:00 AM in the Grey Room of Garvey Commons, SCSU Campus. Board Members Present: <u>Bea Kehr</u>, <u>Pat Hatlevig</u>, <u>Pat Irsfeld</u>, <u>John Ertz</u>, <u>Mark Lee</u>, <u>Mike Bjork</u>, <u>Doug Riles</u>, <u>Leanne Carmany</u>, <u>John Palmer</u>, <u>Joe Christensen</u>. Board Alternates: <u>Dick Hatlevig</u>, <u>Warren Dumuth</u>, <u>Mike LaBerge</u>.

Moved acceptance of the 2011 Conference minutes as mailed to members; seconded the motion; motion was approved. The treasurer's report was distributed; it indicated a MDTSEA balance of \$18,071.40. Mike Bjork moved acceptance of the treasurer's report; Warren Demuth seconded the motion; motion was approved. Discussion of the new accounting system, Quickbooks, was held. Quickbooks will be set up to reflect the budget areas of MDTSEA.

Discussion on the 2012 budget was held. John Ertz moved that the budget be approved; Leanne Carmany seconded the motion; motion approved.

#### The Audit Committee had no report.

The Awards Committee reminded all members that **Teacher of Excellence** nominations and completed applications are due prior to the December board meeting. Send nominations and completed applications to Mark Lee. Presentation of the **Teacher of Excellence** award will be moved back to the banquet.

Pat Irsfeld turned **the Conference and Winter Workshops** report over to Joe Christensen. The workshops will be January 17<sup>th</sup> and 18<sup>th</sup>. Joe will ask the places holding the workshops to pencil in the following week's dates in case of bad weather (January 24<sup>th</sup> and 25<sup>th</sup>). Joe asked for suggestions for workshop topics. Discussion followed.

The 2012 Conference will be held April 13<sup>th</sup> and 14<sup>th</sup> at the Kelly Inn in St. Cloud, MN. Topics and speakers for the Conference were discussed. Joe will see who and what is available and build an agenda from that.

Discussion on whether or not we should allow commercial schools attendance at the winter workshops was held. It was decided that since our purpose is to teach young people to drive safely and defensively, we should offer the workshop to all. If they are a member in good standing with their organization, and their mission is the same as ours, then they should be allowed to pay our member fee of \$25.00 to attend the meetings. If they are not a member of an organization then they will pay the non-member fee of \$40.00.

The Curriculum Committee report was given by Pat Irsfeld. He presented the cost of printing the manual since the state of Minnesota no longer provides manuals for our students. After a lengthy discussion, it was decided to refer this matter to the MDTSEA Foundation as they are a non-profit group.

The Executive Committee had no report.

The Historian had no report.

The Legislative Committee had no report because the legislature was tied up with the budget problems the entire session. It was said that we need a Senator to carry our bill through the senate.

John Ertz and Mike LaBerge reported for the **Membership Committee.** They have been brainstorming many varied ways to improve our membership. They suggested allowing member only access to parts of our website; reaching out to other active driver education teachers; incentives to members who recruit new members; possible classroom liability insurance and many others. This was referred to the membership committee for further exploration. They will look into getting the names of all certified driver education teachers.

The Nomination's Committee had no report.

The Public Relations and Publications report was read by President Kehr. The editor would like to have articles in a timely manner so he can make his deadlines.

**The SCSU report** was read by President Kehr. SCSU continues to lead the nation in Driver Safety Education. Fall enrollment is 11 students, and it currently services 15 states. CONTINUED .....





The ADTSEA report was given. It was stated that nothing is really happening out there. We need updated delivery of an updated curriculum to meet the needs of our students.

**The MDTSEA Foundation Report** was given. Foundation balance was reported as \$14,881.76. Tax exempt status is still in paperwork. The Foundation needs 3 trustees.

#### **New Business:**

Mark Lee moved that we increase the Executive Committee budget by \$500.00. John Ertz seconded the motion and the motion was approved. The new budget is reflected below.
